# **Publication** process

Manuscript reception and registration→Initial review by scientific editor→Peer review→End of peer review→First round of meeting evaluation→To be accepted $\rightarrow$ Revision by the author(s) $\rightarrow$ Second round of meeting evaluation $\rightarrow$ To be accepted/revised/rejected-Final review by the Editor-in-Chief (final quality control for academic content and language quality)→Final acceptance and charging of publication fee-Language editing-Production-Proofreading by scientific editor→Proofreading by deputy editor→Final review by Editor-in-Chief→Release of online open-access papers in electronic form on the BPG website-Release of online papers on PubMed Central-Delivery of high-quality PDF reprints to the author(s)→End of the publication process.
