Reviewer#1:

A case of pancreatic metastasis from lung squamous cell cancer with tracheoesophageal fistulae is reported. Some similar cases have been reported previously and are mentioned in the literature review section. Even though the case has rare complications, we believe that its novelty is still insufficient. And slight language polishing may be necessary.

Answer:

We are grateful for your consideration of this manuscript, and we also appreciate your suggestions, which have been very helpful in improving the manuscript. We thank you very much for your careful reading of our text. I believe that pancreatic metastasis from squamous cell lung carcinoma has been reported in the literature, however this is the unique case of tracheoesophageal fistula as rare complication of squamous cell lung carcinoma with pancreatic metastasis. All the comments we received on this study have been taken into account in improving the quality of the article. Another evaluation of English language has been done by American Journal Experts.

Answer:

We agree with the reviewer that similar cases has been reported in the literature. However, we believe this is the unique case complicated by tracheoesophageal fistula as rare complication of squamous cell lung carcinoma with pancreatic metastasis, we add also an effective systematic literature review to provide an exhaustive summary of current literature relevant to pancreatic metastasis from squamous cell lung carcinoma. We appreciate the reviewer's insightful suggestion and agree that it would be useful to modify the language polishing. For this reason, another evaluation of English language has been done by American Journal Editing before submitting the manuscript revision.
