Key Words	2	Four to seven key words—include “case report” as one of the key words	<u>2</u>
Abstract	3a	Background: What does this case report add to the medical literature?	<u>2</u>
	3b	Case summary: chief complaint, diagnoses, interventions, and outcomes	<u>2</u>
	3c	Conclusion: What is the main “take-away” lesson from this case?	<u>2</u>
Introduction	4	The current standard of care and contributions of this case—with references (1-2 paragraphs)	<u>1</u>
Timeline	5	Information from this case report organized into a timeline (table or figure)	<u>4</u>
Patient Information	6a	De-identified demographic and other patient or client specific information	<u>4</u>
	6b	Chief complaint—what prompted this visit?	<u>4</u>
	6c	Relevant history including past interventions and outcomes	<u>5</u>
Physical Exam	7	Relevant physical examination findings	<u>5</u>
Diagnostic Assessment	8a	Evaluations such as surveys, laboratory testing, imaging, etc.	<u>5</u>
	8b	Diagnostic reasoning including other diagnoses considered and challenges	<u>5</u>
	8c	Consider tables or figures linking assessment, diagnoses and interventions	<u>5</u>
	8d	Prognostic characteristics where applicable	<u>6</u>
Interventions	9a	Types such as life-style recommendations, treatments, medications, surgery	<u>5-6</u>
	9b	Intervention administration such as dosage, frequency and duration	<u>5-6</u>
	9c	Note changes in intervention with explanation	<u>6</u>

Follow-up and Outcomes	10a	Clinician assessment (and patient or client assessed outcomes when appropriate)	<u>6</u>
