In conclusion, a description seems too general: "Venous hemangioma is rare in adults, and an accurate diagnosis before surgery is challenging. Surgery is the curative treatment for venous hemangioma, and the definitive diagnosis relies on pathology." That knowledge was well established to our current knowledge; therefore, the authors should give a new perspective to the reader after reading this good case report. The authors, please consider changing the conclusions to more informative to the reader. -3 Key words. Do the key words reflect the focus of the manuscript? Maybe. However, a keyword could not be found in the Medical Subject Headings (MeSH) (available from https://meshb.nlm.nih.gov): "Retroperitoneal mass." Changing to the appropriate term might be suitable. -4 Background. Does the manuscript adequately describe the background, present status and significance of the study? Yes -5 Methods.
