Reviewer #3: Dear Authors, Thank you for conducting this interesting study entitled "Unusual etiology of epigastric pain: A case report of single organ hepatic artery vasculitis" for possible publication in the esteemed journal "World Journal of Hepatology". The manuscript can be accepted for publication after major revision because of the following comments: 1. The main file didn't contain the following: a. Title of the article. b. Running title. c. Authors names and affiliations. d. Authors' contributions. e. Corresponding author. f. Consent (verbal or informed) from the patient. g. Funding sources. h. Conflict of interest. 2. Minor editing and language corrections are necessary. We highlighted some of the words or sentences in yellow color in the main file that need revision. 3. I suggest the following title "Single organ hepatic artery vasculitis as an unusual cause of epigastric pain: A case report" 4. Introduction: It is better to add the possible mechanisms or causes of the SOV. 5. Case presentation: History of present illness: this sentence "The patient first developed days of diffuse abdominal pain" is unclear, therefore, you should be clarified. 6. Discussion: This paragraph "In a ten-year study review of 130,000 GI histological specimens from biopsies or surgical resections, only 29 (0.02%) patients with vasculitis were identified, of which eight had SOV in the gallbladder, small and large bowels. Notably, there were no hepatic manifestations." Needs a reference. 7. There is no conclusion in the main text. 8. References: a. The references in the text should follow the journal style. b. You can depend on this review article "Localized Forms of Vasculitis" <https://pubmed.ncbi.nlm.nih.gov/34196889/> in your revision. c. You must add the DOI and PMID for each article as per journal style.

Author: Significant changes were made to the manuscript. A discussion on mechanism of action for SOV was included in the introduction. Grammatical and spelling edits were made. The cover letter was changed to include the information requested. We reference the requested article.
