SPECIFIC COMMENTS TO AUTHORS

Dear colleagues! I read with interest your manuscript "Baishideng's Reference Citation Analysis database announces the first Journal Article Influence Index of 101 core journals in gastroenterology and hepatology" which is an Editorial. It provides the data about new scientometric system, the Reference Citation Analysis, the Journal Article Influence Index and top-twenty journals in the field of gastroenterology and hepatology according to the index. This information is important and evidently should be published. There is no major flaws and the paper may be published as is. I have only a few minor notes/suggestions. Although there is no strict rules for the structure of Editorials (according to the guidelines for manuscript preparation), I would suggest to organize it according to the general structure of scientific papers: introduction, methods, results, discussion, conclusions (even if not using these specific section's names). In the Introduction I would add some information on the need for yet another index and rating (this information is already present, at least in part, in the RCA'S MISSION paragraph). In Methods, it would be possible to transfer the data of CALCULATION METHOD OF 2022 JAII and EVALUATION PROCESS OF RCA JOURNALS; the Results may contain the data on the top-twenty journals in gastroenterology and hepatology by JAII. In the Discussion it would be possible to leave INCLUSION PRINCIPLES OF RCA JOURNAL, but I would suggest to add some information on the similarity of the results obtained with the use of JAII with previously existed indexes, possible drawbacks of JAII (if any), or what the new system evidently not able to provide, from the viewpoint of scientometric evaluation, of course. For sure, these comments are only suggestions, and,

Matters to consider: Is it correct to show the cover of one specific issue of the journals on figures? Why the issues of the journals are of different date? Won't the publication of these images lead to copyright issues? Some of these cover pages are of low resolution (fig. 6, 9, 11, 12, 15 and 20). The photo of the Editorial board member, Nikolaos Papadopoulos on the cover image of WJG (fig. 18) may require his consent.
