Field of Vision, Case Report and Letter to the Editor: Non-structured abstract that is no less than 150 words. Research articles: Structured abstract with subsections for AIM (no more than 20 words); METHODS (no less than 80 words); RESULTS (no less than 120 words); and CONCLUSION (no more than 26 words). The 'Key words' list provides 5-10 keywords that reflect the main 12 content of the study. The first letter of each keyword is capitalized, [Y] and each keyword is separated by a semicolon. The "citation" contains authors' names and manuscript title.
