This section can effectively include some information concerning search strategy and the narrative technique. 3. It is suggested that the discussion section be reconsidered in terms of study limitations. 4.

A conclusion section should be added to the end of the article. This section can be briefly described the implications of the study, followed by recommendations for future studies. 5. Finally, I suggest that the manuscript is proofread by a native English speaker or Editing service. So please make sure there are no English errors.
