The authors should to be clarified and be added the following issues in the text. 1. Please add the cost-effectiveness of the laparoscopic surgery and open surgery in the management of Crohn's disease. 2. Because of several different interventions commonly seen with Crohn's disease, these operative approaches depend on the experience and skill of surgeon and the patients' characteristics including age and ASA physical status. 3. The clinical application of the study is very important. The authors should to be recommended the readers to apply this knowledge into routine clinical practice. 4. Please edit the references into the journal style. Thank you so much
