Please compare important preoperative and intraoperative variables such as BMI, preoperative comorbidities, degree of immunosuppression, time interval between the liver transplant and joint replacement, performance status of the patient before joint replacement, liver and kidney functions of the patients before joint replacement, intraoperative blood loss, etc. between the two groups to overcome the potential bias by confounding factors. 4. Please cite the tables at the appropriate places in the manuscript. 5. Please mention the duration of the hospital stay of the two groups. 6.
