I have gone through this manuscript which has been written well and will contribute significant value to the scientific domain, particularly in the management of gestational diabetes. However, there are some minor issues, which need to be corrected before final publication. 1. Some authors affiliations are written in Spanish, particularly for the authors from Mexico. Please note that since the official language of the journal is English so all authors affiliations need to be written in English rather than any other lanugage. 2. The last and corresponding author Salim Surani has been displayed twice on the authors list with two different affiliations but the same author cannot be displayed twice in an article if s/he has multiple affiliations. So both the affiliations of this author need to be written after one name but not separately by using two same names. 3. It is crucial to use the institutional email address at least for corresponding author in order to ascertain the authenticity of affiliations. However, currently corresponding author used a hotmail address so please ask the author to supply the institutional email address which can be from one of the two affiliations and incorporate accordingly. 4. Page 9, las line,correct the sentence as a resting trend......instead
