The review could also benefit from the addition of figures, diagrams, or tables, as suggested to the authors. To the This review is well written and very informative, covering almost all the state of the art on the subject. The content fully reflects what is stated in the title. Abstract, discussion and outcomes are sufficiently, yet not completely, developed. All the main comments have been inserted in the attached text (87121-Manuscript File (with comments)). Here the major points: The review suffers from a lack of images, diagrams or tables; only one image has been included. Diagrams, tables or graphics play an important part in a better understanding of the content and should be featured in a review covering such a broad topic. There are
