		<ul> <li>Welfare-related assessments and interventions that were carried out prior to, during, or after the experiment.</li> </ul>	
Sample size	10	<ul> <li>a. Specify the total number of animals used in each experiment, and the number of animals in each experimental group.</li> </ul>	
		<ul> <li>Explain how the number of animals was arrived at. Provide details of any sample size calculation used.</li> </ul>	page #5
		<ul> <li>c. Indicate the number of independent replications of each experiment, if relevant.</li> </ul>
