For references not yet included in PubMed: the name of Chinese journals is spelled out using Chinese Pinyin, with the first letter of each word capitalized (e.g., Shijie Huaren Xiaolua Zazhi); the name of journals in other languages are listed according to indexing information retrieved from Google. Book references are presented with all the information relevant to the electronic version. The number of cited references is appropriate for the article type, as follows: Commentary; no less than 50; Review; no less than 100; Article; no less than 30/26; Case Report and Letter to the Editor; no less than 1. The ethics-related statements are provided in accordance with the manuscript type (e.g., Manuscript NoInstitutional review board statement, Manuscript NoAnimal care and use statement, etc.).
