Science Editor: Dear Sirs, I have completed the review of the manuscript referred to on the F6Publishing system page. Anyway, I attach my comments here. 1. The authors carried out a retrospective study on the treatment of ectopic pancreas located in the gastric region and defined its characteristics in the endoscopic ultrasound study (EUS). The title adequately reflects the content of the manuscript. 2. Acronyms (GIST) should be identified the first time they appear in the text. 3. The authors present their work as the first to compare the results of laparoscopic or endoscopic treatment using ESD. Given that the laparoscopic group represents 12% of the total (6 cases VS 43), it cannot be considered a true comparative study, especially when it is a retrospective study in which the selection of the technique is not randomized or protocolized. 4. There are excessively long and irrelevant paragraphs, such as the description made of the laparoscopic procedure example, given that this is not standardized. 5. The second paragraph of the discussion refers to the pathogenesis of this pathology. This should be included in the introduction. Best Regards, J.C. Martín del Olmo, MD, PhD. SCG-HMDC.
