In consequence I consider that it can be published. Some considerations: 1. The patient was diagnosed with gastric carcinoma stage IV a year before and, despite different treatments, the disease continued progressing. In consequence, it is hard to sustain that the delay on making the diagnosis of cutaneous metastasis would negatively influence on patient prognosis or survival. I consider that the sentence ..." the best treatment opportunity was missed", which is included in the Core tip and also in the Discussion has to be removed. 2. Considering that breast cancer is the most frequent malignant tumor which presents cutaneous metastasis, an article about it must be included in the Bibliography. 3. The English needs some revision.
