The manuscript is overall qualified. (1) Advantages and disadvantages: The reviewers have given positive peer-review reports for the manuscript. Classification: Grade B and Grade C; Language Quality: Grade B and Grade B. This is a very interesting topic. In traditional understanding, portal hypertension (PH) in advanced liver fibrosis or cirrhosis is an important complication and the main cause of ascites, splenomegaly, and upper gastrointestinal bleeding. However, few studies have focused on the presence of PH in different stages of non-alcoholic fatty liver disease, which is actually quite astonishing. However, before publication, the authors still need to clarify some issues. For example, in the part of Impact of lipid accumulation on PH development in early non-alcoholic fatty liver disease (NAFLD), the description is slightly lengthy and not hierarchical. Things like lipid accumulation and neutrophil chemotaxis, and related clinical trials could be addressed in segments, and shouldn't this section focus on the effects of lipid accumulation on PH? Lack of innovation, similar reviews have been reported on the relationship between portal hypertension and NAFLD and discussions can be added in targeting PH for NAFLD treatment, etc. (2) Main manuscript
