Science Editor: 1 Conflict of interest statement: Academic Editor has no conflict of interest. 2 Academic misconduct: No academic misconduct was found. 3 Scientific quality: The authors submitted a retrospective cohort study of effectiveness of antibiotic prophylaxis for acute esophageal variceal bleeding in patients with band ligation. The manuscript is overall qualified. (1) Advantages and disadvantages: The reviewers have given positive peer-review reports for the manuscript. Classification: Grade A and Grade C; Language Quality: Grade A and Grade A. An important and interesting topic that has been taken for granted for years. However, the authors should clarify the following: (1) Do all currently valid guidelines recommend antibiotic prophylaxis for bleed control? If not, do they make a distinction between EVL and EIS, presence or absence of ascites, and ranking as per Child or MELD status? This is important as it then justifies the need for such a study in all patients undergoing EVL; (2) How many patients in the authors' cohort had ascites / pre-existing SBP? and (3) Is there any way to know why the endoscopists chose to administer antibiotics in individual patients? (2) Main manuscript content: The author clearly stated the purpose of the study and the research structure is complete. However, the manuscript is still required a further revision according to the detailed comments listed below. (3) Table(s) and figure(s): There are 5 Figures and 6 Tables should be improved. Detailed suggestions for each are listed in the specific comments
