Patient Information	6a	De-identified demographic and other patient or client specific information	<u>2-6/5</u>
	6b	Chief complaint—what prompted this visit?	<u> </u>
	6c	Relevant history including past interventions and outcomes	<u> </u>
Physical Exam	7	Relevant physical examination findings	<u> </u>
Diagnostic Assessment	8a	Evaluations such as surveys, laboratory testing, imaging, etc.	<u> </u>
