The handling time of the ethics and relevant documents for clinical and basic researches is calculated as 3 hours, for case reports and other types of manuscript is calculated as 2 hours.</p> <p>If any errors are found in ethics and relevant document after a manuscript is published, a fine of 500 CNY will be imposed on the Scientific Editor for the manuscript, which will be deducted from the Scientific Editor's Welfare provided by the Baishideng Publishing Group.</p>
