Patient Information	6a	De-identified demographic and other patient or client specific information	<u>5</u>
	6b	Chief complaint—what prompted this visit?	<u>5</u>

Physical Exam	7	Relevant physical examination findings	<u>6</u>
Diagnostic Assessment	8a	Evaluations such as surveys, laboratory testing, imaging, etc.	<u>6.7</u>
