The manuscript is overall qualified. (1) Advantages and disadvantages: The reviewers have given positive peer-review reports for the manuscript. Classification: Grade B; Language Quality: Grade B. To strengthen and highlight the content, it is recommended to add some numbers. For example, display the relationship between the acceptance rate of manuscripts and the total number of submissions for each of the 13 Baishideng journals in the chart. The measures taken by publishers to detect plagiarism are also useful, even if they were adopted from the beginning. Plagiarism is a major concern for all journals, so it is useful to report on how publishers have addressed this issue and how many submitted articles (if any) have been rejected due to this issue. (2) Main manuscript content: The author clearly stated the purpose of the study and the research structure is complete. However, the manuscript still require a further revision according</p>	[Y]

(4) References: A total of 10 references are cited, all of which were published in the last 3 years. The reviewer didn't request the authors to cite improper references published by him/herself. 4 Language evaluation: The English-language grammatical presentation needs to be improved to a certain extent. There are many errors in grammar and format, throughout the entire manuscript.
