AUTHORS' REPLIES TO REVIEWERS' CRITICISMS

Reviewer 1

1) It is too long: I believe that a significant shortening could be obtained by reduction of paragraphs on clinical presentation, lithotripsy, and emerging surgical techniques.

The paper has been entirely re-edited and shortened by 1557 words, in particular reducing the paragraphs on clinical presentation, lithotripsy, and emerging surgical techniques, in accordance with reviewer's request.

2) Too much abbreviations sometimes make difficult the reading

In accordance with the reviewer, the abbreviations “GB” for gallbladder, “LC” for laparoscopic cholecystectomy, “ES” for endoscopic sphincterotomy and “MRI” for magnetic resonance has been changed in their extended forms through all the text.

3) As reader I need a more critical appraisal of the Literature's messages

In accordance with the reviewer, a more critical appraisal of literature’s messages, especially when ambiguous or contradictory, has been added through the whole paper, in particular considering drawbacks and morbidity of examinations and procedures.

4) As reader I need also a brief list of the evidence's messages (also in a table)

In accordance with the reviewer, table 1 has been added in order to clarify the main evidence's messages of CBDS diagnosis and management.

Reviewer 2

The author reviewed present approaches in dealing with CBDS in detail, almost of all the procedures and new techniques were introduced, which is of great significance in guidance of clinical practice.
