2	<i>Editorial Office's Comments</i> Science Editor: Dear Editorial Team, I would be grateful for your attention on the following matter: I note Reviewer 1 mentions that the manuscript should be "enriched with original and educative content. Major issue 1) The authors are kindly requested to provide some representative educative material (e.g. figures, videos) regarding the diagnostic approach and the management of hepatolithiasis." and also that "Minor issues 3) Figure 2 is inaccessible; the authors are kindly requested to properly revise it." I am not sure why Reviewer 1 finds Figure 2 "inaccessible" but this is a major problem which may have affected their judgement and grading, since what they are highlighting as a Major issue of the manuscript is the lack of what is essentially included in Figure 2! Figure 2 is indeed a "representative educative material" created by our team following our study of the literature, and provides in a synthetic fashion, a schematic summary of the management of hepatolithiasis. As such, we feel that it is not possible for any reviewer to have a complete and accurate opinion on our manuscript without this very important figure. Therefore, we kindly request that they be sent Figure 2 separately and asked to	[Y]

re-evaluate the manuscript accordingly. To facilitate this process, I have attached herein the relevant figure on a Word file. Its legend is "Figure 2 Schematic summary of the main treatments of hepatolithiasis according to clinical presentation. POCSL: peroral Cholangioscopy with lithotomy; PTCSL: percutaneous transhepatic cholangioscopic lithotomy" We look forward to the resolution of this matter.

Company Editor-in-Chief: I have reviewed the Peer-Review Report, full text of the manuscript, all of which have met the basic publishing requirements of the World Journal of Gastroenterology, and the manuscript is conditionally accepted.
