COMMENTS TO AUTHORS

Well written article that provides a very good, over-all reasonably balanced interpretation of the role of neuropathic pain mechanisms in LBP. - While the outcome of medications is stated as being 'significant' on a number of occasions, perhaps a comment on the affect sizes would be beneficial. This could be a global statement. - The first sentence of the conclusion requires grammatical correction. - A multimodal approach to medication probably is more rational, but I think this needs to be tempered by a statement that a lot of further research is required. Part of this could be identifying sub-groups of likely responders to specific medications/combinations of medications.

COMMENTS TO AUTHORS

Interesting paper which needs minor revisions before publication: 1. Tilidin in the mentioned field of (synthetic) opioids is missing. 2. Concerning adverse drug events especially in TCAs a critical appraisal would be beneficial, citing e.g. the well known PRICUS list. 3. "These sensory testings seem the most important part of this clinical examination" - What's with biomechanical findings in the clinical examination derived from chiorthrapy (i.e. testing of the affected joint, testing of the spine concerning the Lovett`rules)? 4. Emphasizing the pharmacological approach within the neuropathic LBP the use of ascorbic acid is missing. 5. From my point of view the part "discussion" with explanation of limitations is missing: A clear differentiation between a singular neuropathic LBP and classical signs of radiculopathy within the dermatom and (maybe) neurosurgical consequences is missing. Furthermore a critical appraisal of recent studies concerning the frequency of neuropathic and nozizeptive LBP is missing. 6. Structure of the paper: Where is the declaration of conflicts of interests?
