COMMENTS TO AUTHORS

Comments to the manuscript entitled: Myoepithelial carcinoma of the stomach: A diagnostic pitfall. From the authors Chih-En Tseng et al. It is a very interesting case report to be innovative in daily clinical practice, although it is advisable that the authors tell from the title that this is a case report.

Comments Abstract: It is recommended that the authors present the clinical symptoms presented by the patient at the time of the query, or at least explain what is meant by discomfort (abdominal distension, pain, vomiting, hematemesis, hematochezia, constipation, diarrhea, or weight loss, etc.). The authors report that patients are well at present, but do not mention what kind of treatment or intervention was followed, so it is recommended that authors describe shortly, the latter aspect.

Introduction: In the last three lines of the introduction, the authors say is the second case presented, but do not tell if it locally or internationally. It is recommended that the authors describe the acronyms used as follows: EWSR1, especially at the beginning of the document. In Figure 2, A, B, C and D, it is recommended that the authors highlight the microscopically findings of using arrows. It is important that authors describe more details of the clinical history of the patient, for example, as was the onset of clinical symptoms presented by the patient, time of evolution, the effects on the general condition of the patient or example the following: the body weight, the presence of fatigue, the trouble eating certain foods, the symptoms that the patients presented when ingested the different food groups. Also describe the characteristics of the main symptoms and treatment to which the patient was subjected to treat her symptoms, etc. In Table 1, it is recommended to attach a
