### Abstract

#### BACKGROUND

Eosinophilic gastroenteritis (EGE) is a rare disease which presents many unspecific gastroenterological symptoms. The disease includes three types, depending on the depth of eosinophil infiltration in gastrointestinal tract. The serosal type is the most rare, presenting with ascites.
