The manuscript entitled, "Hepatitis C, stigma and cure", reviewed the treatment of patients infected with hepatitis C virus (HCV) and its physiological and mental impacts on patients. Authors reviewed the topics compactly, however, it seems rather too concise. (Major comments) 1. In case authors try to attach weight to mental impact and quality of life during and after treatment for HCV, you can reinforce the descriptions with some clinical results (references). 2. In the present form, descriptions for "physiological" aspect and "mental" aspect of the impact of HCV infection and its treatment are presented discretely, which makes the review difficult to follow.
