Please revise the entire manuscript for the correct use of abbreviations. Some rules must be observed: they should be defined upon first mention in both the abstract and the main text; as a rule, if an abbreviation is not going to be used more than three times just write the full name. - Please revise grammar, spelling, and word usage throughout the manuscript. Several related problems even compromise the logical sequence of sentences. - Whilst ideas are presented in a logical order and one can transition between ideas, the paragraphs throughout the text need further improvement. Please give an overview of the paragraph and follow with details. Some paragraphs are too short in the current version. - Abbreviations used in Table 2 must be defined. - On page 10, please revise the sentence 'which uses injection of a chemotherapeutic agent into the hepatic artery, followed by obstruction of the hepatic artery'. It is more appropriate to specify that the procedures must target the tumour-feeding artery. Obstruction of the hepatic artery itself can be disastrous.

Response: We greatly appreciate your comments and suggestions to improve our manuscript.

- a. The abbreviations were changed in the format suggested by the reviewer.
- b. The full manuscript was thoroughly revised and grammar and spelling was improved.
