Answer Step 1: We selected to revise the manuscript

Step 2: *Key points of revising the manuscript*

(1) Scientific quality: Please resolve all issues in the manuscript based on the peer review report and make a point-to-point response to the issues raised in the peer review report.

Answer Step 2 (1): There are no issues raised in the peer review report concerning scientific quality and therefore no point-to point response can be made.

Specific Comments to Authors: The manuscript written by Suttorp M. et al. describes the achievements and future directions of The International Registry on Pediatric CML (IR-PCML). Since pediatric CML is rare and it thus important to collect all data on the diagnosis, treatment, and prognosis for the future advances in the management of the disease. From that point of view, the role of IR-PCML would be very important, and the manuscript could provide valuable information to the various physicians.

Answer Step 5: From our point of judgement there are no issues raised by the reviewer requiring any changes in the text.
