### **Reviewer:**

**1. This manuscript was well-written about the prognosis values of modified Lauren classification in gastric cancer, compared to differentiation grade and Lauren classification. The authors proposed a novel prognostic model for predicting the overall survival in patients who underwent the gastric cancer surgery. Statistical analyses were appropriately performed for comparison of AUCs between the models.**

Thank you very much for your positive comments.

**2. Hanley and McNeil test is considered when the values of AUC are  $> 0.7$  and it does not give the covariance between the two AUCs. In the present study, AUCs of three pathological classification (Table 3) were less than 0.7, except for 5-year overall survival of modified Lauren classification. Instead, Delong method or Li's method may provide more exact estimation of the difference between two AUCs (references: Biometrics 1988;44:837-45 and Stat Med 2008;27:224-42). Please consider the statistical consultation again.**

Thank you for pointing out this important issue. According to this comment, we applied the Delong method as the reviewer recommended, to newly calculated AUC values and the differences of AUC values (Table 3; Table 4; page 7, line. 178; page 8, line. 213; page 9, lines. 215-216, 220; and page 10, line. 251).
