### COMMENTS TO AUTHORS

I read the paper, entitled "Recurrent Intestinal Intussusception as First Clinical Manifestation of Primary Intestinal Melanoma: Case Report and Review of the Literature" by Kouladouros K et al. My comments are as follow. 1. The authors reported an interesting case of recurrent intussusception in an adult induced by malignant melanoma. The reason of indication for second surgical intervention is still unclear. Why did the authors perform a second surgical attempt in spite of poor prognosis of melanoma? 2. One of important points of this case report is that this case is an intussusception induced by melanoma. The authors described that only 8 cases of primary malignant melanoma of the small bowel leading to enteric intussusception have been reported in the international literature. The additional table in which summarized characteristics of these cases would be helpful to convince the contents in the text. 3. Discussion section is too long, which include previously known issues. The authors should focus on important issues associated with this case, including intussusception induced by malignant melanoma. Conclusion should be also described simply to indicate teaching points. 4. Abbreviations should be defined at first appearances (i.e., FDG-PET-CT). 5. In figure legend of Figure 1, "left" and "right" should change to "a" or "b" with labelling in the figure.
