

## Questionnaire form for hospital administrators (descriptions abbreviated)

### Question One

Select up to five patients who were staying at your hospital under order of the prefectural governor on June 30, 2014. Please select one option that most matches the status of each patient on June 30, 2015 and June 30, 2016.

(1) Staying at your hospital:

1-1 staying at your hospital under the prefectural governor's order

1-2 staying at your hospital after the dismissal of the prefectural governor's order

1-3 staying at your hospital after discharge (once discharged but readmitted)

1-4 staying at your hospital (not in a psychiatric ward but in a physical care ward)

(2) Regularly visiting an outpatient unit at your hospital:

2-1 regularly visiting an outpatient unit at your hospital after discharge

2-2 regularly visiting an outpatient unit at your hospital (after events such as readmission or withdrawal from treatment)

(3) Staying at a hospital other than yours:

3-1 staying at a hospital other than yours after moving hospital under the prefectural governor's order

3-2 staying at a hospital other than yours after dismissal of the prefectural governor's order

3-3 staying at another hospital after discharge (once discharged but readmitted)

3-4 staying at another hospital (not in a psychiatric ward but in a physical care ward)

(4) Regularly visiting an outpatient unit at another hospital:

4-1 regularly visiting an outpatient unit at another hospital since being moved to another hospital during admission

4-2 regularly visiting an outpatient unit at another hospital since being referred to another hospital at the time of discharge

4-3 regularly visiting an outpatient unit at another hospital since being referred to another hospital after discharge

(5) Prognosis unknown:

5-1 prognosis unknown because which outpatient unit the patient should visit was not determined after discharge

5-2 prognosis unknown after moving hospitals under the prefectural governor's order

5-3 prognosis unknown after moving hospitals at the time the prefectural governor's order was dismissed

5-4 prognosis unknown after referral to an outpatient unit at another hospital at the time of

discharge

5-5 prognosis unknown after referral to an outpatient unit while regularly visiting your outpatient unit

5-6 prognosis unknown after withdrawal from an outpatient unit at your hospital

5-7 prognosis unknown since absconding from your hospital

5-8 prognosis unknown since psychiatric care was terminated at the time of discharge

(6) Deceased:

6-1 deceased for any reasons

(7) Others:

7-1 other prognoses (specify)

## Question Two

Answer whether each care service described below was provided to each patient selected in the previous question.

(1) Multi-disciplinary team meeting for the patient while staying at your hospital under the prefectural governor's order

(2) Identifying the key person for the patient's life in the community

(3) Counseling by public workers while staying at your hospital under the prefectural governor's order

(4) Identifying where the patient would live after discharge

(5) Discussion with persons other than the psychiatrist in charge before dismissal of the prefectural governor's order

(6) Discussion with specialists external to your hospital before dismissal of the prefectural governor's order

(7) Hospitalization continued after dismissal of the prefectural governor's order

(8) Providing nurse visit service after discharge

(9) Providing day- or night-care after discharge

(10) Providing outpatient care services in the community after discharge

(11) Providing residential care services in the community after discharge
