Abstract

BACKGROUND

Paradoxical psoriasis induced by tumor necrosis factor alpha antagonists is a rare side effect of these drugs with similarities with and differences from classical psoriasis in clinical and pathological characteristics. Treating severe paradoxical psoriasis is challenging because the reported cases are rare, with treatment experience being only anecdotal.

We report the case of a 31-year-old woman with extended CD who paradoxically developed psoriasis during her first treatment with infliximab and later with adalimumab. Our patient was diagnosed with CD in March 2006 according to standard endoscopic, radiologic, and histologic criteria. She showed affected terminal ileum and right and transverse colon (A2 L3 and B1 Montreal Classification). She had no history of psoriasis and was otherwise healthy.
