**BACKGROUND**

Urinary bladder hemangioma (UBH) is a benign non-urothelial tumor that rarely occurred in pediatric and adolescent patients . Clinical and radiological examinations are not adequate for an accurate diagnosis. The purpose of this serial case report is to raise awareness of urinary bladder hemangioma and appropriate management.

Introduction. Majority of vascular lesions in the urinary bladder are haemangiomas which comprise 0.6% of all urinary bladder cancers and this makes primary angiosarcoma of the urinary bladder very rare. Jungano referred to an older report from 1905 of a "telangiectasia fibrosarcoma" of the bladder in a 64-year-old man, which by modern criteria may have truly been the first case of angiosarcoma of the urinary bladder.

**Female urinary retention** is rare. **Case presentation.** **Case 1**, a 35-year-old nulliparous woman, and **case 2**, a 47-year-old nulliparous woman, had transient **urinary retention**. A **urodynamics** revealed increased **bladder sensation** in **case 1** and detrusor underactivity with a large post-void residual in **cases 1** and **2**. Both women had a **uterine leiomyoma** of >10 cm in diameter.
