Abstract

BACKGROUND

Several cutaneous manifestations such as urticarial rash, erythematous patches and chilblain-like lesions have been described in young adults with COVID-19 and are present in up to 20% patients, but few reports exist describing histopathological and immunophenotypic characteristics of dermatological lesions in older patients. Our aim was to characterize skin lesions in elderly patients during late stages of COVID-19 from clinical, histological and immunophenotypic perspectives.


