Sep 30, 2014 · A foreign body protruding from the tear was found to be a 2.5×0.2-cm **fish bone** (Fig. 3). The procedure was completed with the suturing of the injured serosa with 2 stitches. These findings indicate that the mass-like lesion was a gastric pseudotumoral lesion caused by the impacted **fish bone**. The patient's post-operative course was uneventful.

Pylephlebitis, or infective thrombosis of the portal vein, is a serious condition with significant morbidity and mortality, which can complicate intraabdominal infection of any etiology that occurs in the region drained by the portal venous system. The diagnosis of **pylephlebitis** requires the demonstration of portal vein thrombosis, usually accompanied by bacteremia in a febrile patient.
