Abstract. The cumulative rates of **HBV reactivation** at 6 months, 1 year, and 2 years were 22.6%, 29.3%, and 41.5%, respectively (Fig 2 A). Nineteen patients (30.2%) developed **HBV reactivation** (Table 2) at a median of 23 weeks (range, 4 to 100 weeks) after commencement of rituximab-containing regimens.

In patients with negative HBV surface antigen (HBsAg) and positive antibody to HBV core antigen (anti-HBc), HBV reactivation, termed de novo hepatitis, is defined as HBsAg reappearance with threefold elevated ALT on two consecutive tests 5 days apart and accompanied by an increase in HBV DNA to more than 10⁵ copies/ml [Hui et al. 2006].
