I find it a interesting study, but, there are a number points that may deserve some revisions. 1. The article needs a great deal of language polishing, such as the use of an adjective (gastric) instead of a name (stomach). 2. The format of the article does not conform to the format of case report, and the author needs to adjust the format. 3. The treatment and outcome of patients need to be supplemented, so that the case can be considered complete. Scientific Quality:Grade C Language Quality:Grade B Recommendation:Conditional acceptance.
