Science Editor: 1 Scientific quality: The manuscript describes a case report of the treatment of full-endoscopic spine surgery on lumbar foraminal stenosis induced radiculopathy after osteoporotic vertebral compression fractures. The topic is within the scope of the WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors describe the technique of FESS with PVP for OVCF and LFS due to vertebral compression fractures with good results. The authors have combined two widely practiced procedures to address the individual pathologies into one surgical procedure. The questions raised by the reviewers should be answered; (3) Format: There are 3 figures; (4) References: A total of 21 references are cited, including 10 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
