No academic misconduct was found in the Google/Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; 6 Re-Review: I strongly suggest a re-review of the manuscript by other reviewer. The text is too long for a manuscript. Recommendation: conditional acceptance (after major review)
