2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a retrospective study of the development and validation of a prognostic nomogram for colorectal cancer after surgery. The topic is within the scope of the WJG. (1) Classification: Grade C and Grade C; (2) Summary of the Peer-Review Report: The authors provide a well written manuscript with robust methodology and can have good clinical importance for the management of CRC.</p>	[Y]

However, there are some statements which were mentioned in introduction but also repeated in discussion; and (3) Format: There are 3 tables and 3 figures. (4) References: A total of 26 references are cited, including 6 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com.
