needlessly long. The authors need to provide the source/reference about the possibility of a direct passage of fat cells in the arterial circulation through the pulmonary capillary bed. In the discussion part, authors should put accents on what was extraordinary and challenging in the case. The conclusion part in the abstract is too long. The questions raised by the reviewers should be answered; (3) Format: There is 1 table and 1 figure; (4) References: A total of 18 references are cited, including 6 references published in the last 3 years; (5) Self-cited references: There are no self-citations; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com.
