The management of the case was considered to be innovative and of scientific value. (3) Format: There are 5 figures and no tables in the manuscript, and all figures are of adequate quality. (4) References: Citation of references in the manuscript is sufficient and reasonable. A total of 20 references are cited, of which 4 references were published in the last 3 years. (5) Self-cited references: There are no self-cited references in the manuscript. (6) References recommendations: The reviewers made no references recommendations. 2 Language evaluation: Classification: Grade B (1). The authors have provided a language editing certificate from AJE. 3 Academic norms and rules: The authors have sent a Signed Informed Consent Form, which is correctly provided and meet the standard requirements. While the authors have denied any competing interests in the manuscript, a signed Conflict-of-Interest Disclosure Form was not provided. A CARE Checklist was sent by the authors. No academic misconduct was found by the Google/Bing search. 4 Supplementary comments: This is an unsolicited manuscript. Financial support was not disclosed in the manuscript.
