Summary of the Peer-Review Report: The authors have described a rare case of adenomyoepithelioma of the breast. The authors must address what aspects of the case report can impact the clinical management of this disease. Some clarifications are necessary regarding the description of the histopathological results of the tumor resection. (3) Format: There are 3 figures and no tables in the manuscript, and all figures are of adequate quality. (4) References: Citation of references in the manuscript is sufficient and reasonable. A total of 19 references are cited, of which only 2 references were published in the last 3 years. (5) Self-cited references: There are no self-cited references in the manuscript. (6) References recommendations: The reviewers made no specific reference recommendations. 2 Language evaluation: Classification: Grade B (1). The authors have provided a language editing certificate from Forte. 3 Academic norms and rules: The authors have sent a Signed Informed Consent Form, which is correctly provided and meet the standard requirements. While the authors have denied any conflict of interest in the manuscript, a signed Conflict-of-Interest Disclosure Form was not provided. The authors have provided the CARE Checklist for the manuscript. A Google and Bing search shows the article fully available as a preprint in the Research Square platform, under the 10.21203/rs.3.rs-70838/v1. 4 Supplementary comments: This is an unsolicited manuscript. Financial support was not disclosed in the manuscript. The topic has not previously been published in the
