The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors present an interesting study that emphasized the potential fatal as well as neglected complication of chronic liver disease and also</p>	[Y]

contributing factor of recurrent hepatic encephalopathy. The results are encouraging and further study is warranted. However, the questions raised by the reviewer should be answered; and (3) Format: There are 2 figures. (4) References: A total of 16 references are cited, including 2 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
