case report presented nicely a rare case of intravascular papillary endothelial hyperplasia in the cervicothoracic spinal canal, treated via complete resection with a favorable outcome. The questions raised by the reviewers should be answered; (3) Format: There is 1 table and 4 figures; (4) References: A total of 26 references are cited, including 2 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
