- (2) Summary of the Peer-Review Report: There are some inconsistencies in the writing in english language and in data distribution in the tables that have been detailed by the reviewer.
- (3) Format: There are no figures and 3 tables in the manuscript, and all tables are of adequate quality. (4) References: Citation of references in the manuscript is sufficient in number, but many references are outdated. A total of 26 references are cited, of which only 1 references was published in the last 3 years. (5) Self-cited references: There are no self-cited references in the manuscript.
- (6) References recommendations: The reviewers made no references recommendations. 2 Language evaluation: Classification: Grade B (1). The reviewers have pointed out a number of linguistic inconsistencies that must be addressed by the authors. The authors have provided a language editing certificate from Editage. Academic norms and rules: The authors have sent a Institutional Review Board Approval Form, which is correctly provided and meet the standard requirements. The Instititional Review Board had waived the need for Signed Consent Forms, due to the retrospective nature of the study. While the authors have denied any conflict of interest in the manuscript, a signed Conflict-of-Interest Disclosure Form was not provided. The Biostatistics Review Form was provided as a letter from one of the authors from the study. No academic misconduct was found by the Google/Bing search. 4 Supplementary comments: This is an unsolicited manuscript.

Financial support was not disclosed in the manuscript. The topic
