For citations where no author is indicated, a superscript number should be placed at the end of the sentence. Respective examples are: "Ma <sup>[1]</sup> reported .....", "Pan <i>et al</i> <sup>[2-5]</sup> indicated ....." ; "PCR has a high sensitivity <sup>[6,9]</sup> ." No superscript numbers are used when the reference number is described in the text; for example, "The experimental method used has been described in reference [8]."
