total of 49 references are cited, including 29 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by LetPub was provided. 3 Academic norms and rules: The authors provided the the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by grants from the Zhenjiang Science and Technology Committee. The topic has not previously been published in the AIG. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; and (2) The authors did not provide the approved grant application form(s).
